

EVERYDAY CURRENT AFFAIRS – MAY 16, 2022

TAMIL NADU

- **Automobile major Hyundai Motor India Limited – has won the top exporter award for being the highest foreign exchange earner at the southern region export Excellence awards programme held in Chennai**
- ✓ The company has also won the 'Top 5 star export house' award in the southern region
- ✓ Chief Minister M K Stalin handed over the awards to Hyundai Motor India Limited

NATIONAL

- **The National Highways Logistics Management Ltd (NHLML), a subsidiary of NHAI - has invited bids for the first ever ropeway project for city commuters in India.**
- ✓ The 3.8km ropeway link will connect Varanasi's Cantonment railway station and Godowlia Chowk in Varanasi
- ✓ The project will be developed with an investment of Rs. 461 crore.
- ✓ The ropeway will enable the passengers to travel the total 3.8km in just 17 minutes.
- ✓ A total of 218 cable cars will be deployed to ensure the frequency of this service is in less than a minute.
- ✓ Each car will have 10 seats and at full capacity, around 4,500 people will be able to travel in one hour in one direction.
- ✓ The successful bidder will be responsible for completion of the project in three years and maintain and operate the project for 15 years, according to the bid document.
- **The Ministry of Agriculture & Farmers Welfare – signed an agreement with the United Nations Development Programme (UNDP) for strategic partnership on agriculture, crop insurance and credit**

- ✓ Under the MoU, the UNDP will provide technical support towards Centre's Pradhan Mantri Fasal Bima Yojana scheme (PMFBY) and Kisan Credit Card - Modified Interest Subvention Scheme (KCC-MISS)



- ✓ The MoU was signed in the presence of Union Minister of Agriculture Narendra Singh Tomar and Union Minister of Agriculture for State Kailash Chaudhary on May 12
 - ✓ KCC-MISS and PMFBY were launched to tackle the problematic areas of previous schemes and also to apply uniformly across the entire country with a provision to cover all crops.
 - ✓ The crop insurance scheme, PMFBY was launched in 2016 and is being administered by the Ministry of Agriculture and Farmers Welfare
 - ✓ Kisan Credit Card (KCC) scheme, launched in 1998, provides short-term credit to farmers for their agricultural needs.
- **The Union Ministry of Tourism - has launched an innovative idea of establishing 'YUVA Tourism Clubs' as part of the 'Azadi ka Amrit Mahotsav' celebrations**
- ✓ Supporting the initiative, the Central Board of Secondary Education has given instructions to all CBSE affiliated schools regarding formation of Yuva Tourism Clubs
 - ✓ According to 'Yuva Tourism Clubs– handbook for schools-2022', the clubs will nurture and develop young ambassadors of the Indian tourism.
 - ✓ The tourism clubs will facilitate development of soft skills mainly teamwork, management, leadership and also encourage the adoption of responsible tourism practices and concern for sustainable tourism.
 - ✓ The clubs will help children to be more aware about their States and neighborhood along with the cultural aspects.
 - ✓ The activities of the clubs will integrate with activities of other clubs as tourism, culture, and heritage are also part of subjects taught in school.

- ✓ The teachers and schools are encouraged to incorporate allied activities under Ek Bharat Shreshtha Bharat (EBSB) programme like excursion, online or e-tourism, pen pals in the paired state/UT and learning the language of the paired state/UT
 - ✓ YUVA Tourism Clubs will also enable learners to appreciate the importance of travel and tourism, ignite a passion for tourism and its value in learners, encourage, teach and propagate responsible tourism practices
 - ✓ The Clubs will also improve physical and mental health through exploratory, adventure and sports tourism
 - ✓ They aim to spread awareness about tourism opportunities at an early stage and encourage learners to be skilled professionals and entrepreneurs in the hospitality and tourism sector.
- **On May 13, NITI Aayog - launched the National Data & Analytics Platform (NDAP) for open public use**
- ✓ The platform aims to provide free access to public government data by making them accessible, interoperable, interactive, and available on a user-friendly platform
 - ✓ This public launch follows a beta release of the platform in August 2021 that had provided access to a limited number of users for testing and feedback
 - ✓ NDAP hosts foundational datasets from various government agencies, presents them coherently, and provides tools for analytics and visualisation.
 - ✓ Currently, NDAP hosts 203 datasets and these datasets are chosen based on use-cases and expert advice, interoperable with each other, and easy to download and use.
 - ✓ NDAP also has in-built tools to search, merge, and visualise datasets.

PERSONALITIES

- **Devasahayam Pillai - became the first Indian layman to be declared a saint by the Vatican on May 15**



- ✓ The previous saints from the country were religious people, nuns and priests from the church.
- ✓ Devasahayam Pillai was born a Hindu in Kanyakumari district of Tamil Nadu and converted to Christianity in the 18th century


- ✓ Pope Francis canonised Blessed Devasahayam during the Canonisation Mass in St Peter's Basilica honouring him and nine other new saints
- ✓ The event was attended by over 50,000 faithful from all over the world as well as government delegations
- ✓ Tamil Nadu Ministers T Mano Thangaraj and Gingee KS Masthan and State Minorities Commission chief Peter Alphonse have reached Rome to take part in the canonisation of the Tamil Nadu's first Catholic Saint.
- ✓ Devasahayam was born on April 23, 1712 as Neelakanta Pillai into a Hindu Nair family in Nattalam village in Kanyakumari district, and went on to serve in the court of Marthanda Varma of Travancore.
- ✓ After meeting a Dutch naval commander Eustachius Benedictus De Lannoy at the court, Devasahayam was baptised in 1745, and assumed the name 'Lazarus', meaning 'God is my help'.
- ✓ The Travancore Maharaja was, however, furious about his conversion and shot him dead at Kattadimalai in Aralvaimozhy forest on January 14, 1752
- ✓ He is widely considered a martyr, and his mortal remains were interred inside what is now Saint Francis Xavier's Cathedral in Kottar, Nagercoil.
- ✓ In 2004, the diocese of Kottar along with Tamil Nadu Bishops' Council and Conference of Catholic Bishops of India recommended Devasahayam for beatification.
- ✓ He was declared blessed by the Kottar diocese in 2012, 300 years after his birth.
- ✓ In 2014, Pope Francis recognised a miracle attributed to Devasahayam, clearing the path to his canonization
- ✓ He was approved for sainthood in February 2020 for "enduring increasing hardships" after he decided to embrace Christianity
- ✓ While clearing Devasahayam for sainthood, the Vatican dropped 'Pillai' from his name, and referred to him as "Blessed Devasahayam".

ECONOMY

- **Asia's richest man, Gautam Adani-led Adani group - has acquired a controlling stake in Switzerland-based Holcim AG's cement businesses in India in a deal worth \$10.5 billion.**
- ✓ With this, the Adani group became the second biggest cement producer in the country.
- ✓ This is also the largest-ever acquisition by Adani, and India's largest-ever M&A transaction in the infrastructure and materials space.
- ✓ Holcim owns 63.11% in Ambuja Cements and 54.53% in ACC—the twin assets through which it entered India in 2005
- ✓ Gautam Adani's conglomerate acquired 63.19% of Ambuja Cements Ltd and its subsidiary ACC along with related assets
- ✓ Adani group, the buyer of the two companies, has become the second-biggest player in the country after K M Birla's UltraTech Cement

- ✓ Of the total 540 million tonnes annual capacity in India, UltraTech accounts for 117 million tonnes, while Ambuja Cements-ACC is at 70 million tonnes

- ✓ The two companies, Ambuja Cements-ACC, together have 23 cement plants, 14 grinding stations, 80 ready-mix concrete plants and over 50,000 channel partners across India.
- ✓ Adani group had last year set up two cement subsidiaries -- Adani Cementation Ltd and Adani Cement Ltd -- under Adani Enterprises Ltd.
- ✓ The world's largest cement maker Holcim last month announced its exit from the Indian market after struggling over a long period
- ✓ India is the second largest cement producer in the world after China and accounts for more than 7% of the global installed capacity

AWARDS

- **Anna Qabale Duba, a Kenyan nurse stationed at the Marsabit County Referral Hospital - won the inaugural Aster Guardian Global Nursing Award on May 12**



- ✓ She received the award as the world's best nurse for endorsing education, campaigning against early marriage and outdated cultural practices like Female Genital Mutilation in her community.

- ✓ Duba was the only university-educated girl from Torbi village, and the only girl educated past primary school level in her family of 19 children.
- ✓ Duba was feted by Emirates CEO Sheikh Ahmed bin Saeed Al Maktoum at an award ceremony held in Dubai, which commemorated the International Nurses Day.
- ✓ This is second high-profile award for Duba, having won the Global Citizens' People's Choice Award in New York in 2019.
- ✓ The award was launched in 2021 and received 24,000 nominations from nurses all over the globe
- ✓ Duba was among nine other finalists who were selected by a grand jury for their works in extending humanitarian care in their respective communities.
- ✓ She won \$ 250,000 (approx. Ksh.29 million) in prize money, while the other finalists each took home \$ 5,000 (approx. Ksh.580,000) in prize money
- ✓ Lincy Joseph and Manju Dhandapani were two of the finalists shortlisted from India

SPORTS

- **India - have defeated the 14-time champions Indonesia 3-0 to win the Thomas Cup for the first time on May 15 in Bangkok, Thailand**
- ✓ India had never reached the final of the Thomas and Uber Cup in the tournament's 73-year-long history
- ✓ With this win, India became only the sixth nation after China, Indonesia, Japan, Denmark, and Malaysia to win the Thomas Cup title

Lakshya Sen (20; 9) | The young gun has taken the world by storm, clinching the World Championships ('21) bronze and All England silver this year

HS Prannoy (29; 23) | His lion-hearted show in the quarters and semis that took India to the final. Won CWG gold and Asian Championships bronze in '18

Satwiksairaj Rankireddy (21; 7) | The doubles specialist is a CWG '18 gold medallist and the winner of 2019 Thailand Open

Chirag Shetty (24; 7) | Satwik's partner also won CWG '18 gold and Thailand Open a year later

- ✓ In the first game, the 20-year-old World No. 9, Lakshya Sen powered India to a 1-0 lead with a come-from-behind win over world number five Anthony Sinisuka Ginting
- ✓ Then, India's doubles pair Chirag Shetty and Satwiksairaj Rankireddy defeated World No. 1 and World No. 2 doubles stars Kevin Sanjaya and Mohammad Ahsan in the most sensational victory of their career, to give India a 2-0 lead.

MAJOR MILESTONES IN INDIAN BADMINTON

1980: Prakash Padukone wins All England Championships

1983: Prakash Padukone wins bronze at the World Championships

2001: Pullela Gopichand wins All England Championships

2010: Saina Nehwal wins Commonwealth women's singles gold, Jwala Gutta-Ashwini Ponnappa win women's doubles gold and India win team gold

2011: Jwala-Ashwini bag women's doubles bronze at World Championships

2012: Saina Nehwal wins women's singles bronze at London Olympics

2013: Sindhu wins women's singles bronze at World Championships, she repeats the feat in 2014.

2014: Indian women win Uber Cup bronze

2015: Saina wins silver at World Championships. Become No.1

2016: Sindhu wins silver at Olympics. India win bronze in Uber Cup

2017: Sindhu wins Worlds silver, repeats the feat next year. Saina wins bronze at Worlds. Srikanth wins four Super Series titles.

2018: Srikanth becomes World No.1

2019: Sindhu becomes world champion

2020: Sindhu wins bronze in Olympics.

2022: India are Thomas Cup champions.

- ✓ In the third game, Kidambi Srikanth defeated Asian Games gold medallist Jonatan Christie to seal the historic triumph without losing a game in the finals
- ✓ The former World No. 1 has bagged his second medal for this year after having won the silver at the world championships earlier in 2022.
- ✓ India won the gold medal while Indonesia finished with the silver.
- ✓ This was Indonesia's 21st final at the mega event and it is the most successful team with 14 titles
- ✓ India had not even reached the last-four stage since 1979
- ✓ India has defeated five time champions Malaysia in the quarters and prevailed over 2016 winners Denmark in the semi finals
- ✓ India have lost just one match against Chinese Taipei in the group stage.
- ✓ Denmark and Japan finished with the bronze at the prestigious team championship.
- ✓ Japan had lost 3-2 to Indonesia, while Denmark had lost to eventual champion India 3-2 in the semi finals
- ✓ Union Sports Minister Anurag Thakur has announced Rs 1 crore for the entire team

- ✓ Among Indian players, Lakshya Sen won bronze at the World Championships in his very first attempt in 2021.
- ✓ He became the first Indian man after Pullela Gopichand to reach the final of the All England Championships in 2022.
- ✓ Andhra Pradesh's Satwiksairaj Rankireddy and Maharashtra's Chirag Shetty helped India to win the historic men's team gold in the 2018 Commonwealth Games
- ✓ In 2019, they became the first Indian doubles pair to win the BWF Super 500 event, the Thailand Open
- ✓ Srikanth is the only Indian to become the men's singles World No. 1, a feat he achieved in 2018.
- ✓ In 2017 he became the only Indian to win four Super Series titles
- ✓ He is also the first Indian to win a silver medal at the World Championships (2021).

STATEWISE MONTHLY GST COLLECTIONS – A REPORT

TN IN FOURTH SPOT AMONG STATES IN GST COLLECTIONS

TN continues to be among the top five states bringing in the most Goods and Service Tax (GST) collections on a monthly basis even as the rate at which the collections are growing on a YoY basis lags the gains made by other top states. In April, TN's GST collections stood at ₹9,724 crore, up 10% from the ₹8,849 crore it brought in last April. Maharashtra, Karnataka and Gujarat – that occupied the top three spots – grew their monthly GST collections by 25%, 19%, and 17% respectively. The three states continue to be in the top three spots with TN at the fourth spot on a regular basis.

India's gross GST collection in April at ₹1,67,540 crore was at all-time high, ₹25,000 crore more than the next highest collection of ₹1,42,095 crore in March. Authorities and experts believe this shows a clear improvement in compliance behaviour, a factor that has also historically been the strength of the highly rule-based state of Tamil Nadu
